### WHAT IS THIS GUIDE?

You should use this guide as a reference on how to navigate the new rules, regulations & requirements for the (BTOM) border target operating model effective from January 2024.

### WHAT IS LOW RISK AND MEDIUM RISK?

You will firstly need to ascertain if your product is low risk or medium risk.

Low risk products include: non-raw milk, shelf stable at ambient temperature, whey protein, chocolate, honey and more.

Medium risk products include: raw milk chilled/frozen, Roquefort, cheese, eggs, yoghurt, ice cream (depends how it was made), infant formula, follow-on formula, baby food, food for special medical purposes, apiculture products for human consumption and more.

31/01/2024	<ul> <li>Export health certificates (EHC) start for medium risk</li> <li>Common health entry document (CHED) in IPAFFS for medium risk</li> </ul>
30/04/2024	<ul> <li>ID, physical and document checks start</li> </ul>
31/10/2024	<ul> <li>Safety and security declaration (S&amp;S) required</li> </ul>

The pre-notification in IPAFFS must be completed 4 hours before the cargo arrives in the UK.



#### Border control posts (BCPs)

Low risk and medium risk foods, can only be imported at a point of entry which has a border control post (BCP), which is able to handle the commodity you are importing. Please find list of border control posts (BCP) <u>here</u>.

### **Check Frequency**

Low risk: 0% document, 0% ID and 0% physical check.

Medium Risk: 100% document, 1%-30% ID and 1%-30% physical check.

### **Inspection Fees**

There will be a flat fee on sanitary and phytosanitary (SPS) goods, regardless of whether they get inspected. We are waiting for the UK GOV to confirm.











#### Accredited trusted trader schemes (ATTS)

Certification Logistics Pilot (January 2024) – Allows for the export health certificate to be used from the point of origin (e.g., Manufacturing site), without the need to go to a consolidation hub to have the export health certificate (EHC) approved.

Checks away from border control post (BCP) Pilot (April 2024) – This is similar to the Authorised Operator Status (AOS) for plants. Where you set up your warehouse and train your staff to be able to complete the physical checks there, instead of having to go to a border control post (BCP) for checks.
